## Here is a sample of the questions that other families have wanted to address:

- How much information should we give our children about our wealth and estate plans?
- What are appropriate inheritances for our children, and when should we tell them? How much money should we give—outright or in trust? Should we give them a say in their inheritances?
- My children already have trusts. What are the qualities that I should be looking for in a trustee?
- Should we let our children make their own decisions around a prenuptial arrangement?
- How should I share some of my wealth with my second spouse and her/his children?
- How should we integrate in-laws into our family?
- How should I accept the differences within my family?
- How should we live a life that's consistent with how we want to raise our children?

- How should we raise children in the context of wealth?
  - What can we do for our children to help them find a binding passion and turn it into meaningful work?
  - How do we raise children who will be resilient throughout life's transitions, challenges, and losses?
  - What will my children think if they don't have to work?
  - Can I encourage my children to lead their own lives while staying connected to the family?
- What principles should guide us in our philanthropic work? Should we invite our children and their spouses to be on the board of our family foundation?
- "Shirtsleeves-to-shirtsleeves" in three generations: What can I do to prevent that outcome?
- What does my family need in the future to maintain its strength?
- What should I think about my legacy?
